The following pages present a history of NLRB petition/election statistics and work stoppage statistics—from the Bloomberg BNA Elections, Work Stoppages and Unfair Labor Practice Charges databases respectively—for XYZ from 2002 through 2011. Bloomberg BNA collects petition/election information from the National Labor Relations Board's headquarters and 32 regional offices. Work stoppage data is compiled using published sources only, including newspapers, union publications, Bloomberg BNA labor publications, and government reports.
